Announcing New HSL Online Databases

The Health Sciences Library System is pleased to introduce two new services available through HSL Online: **Evidence-Based Medicine Reviews** (**EBMR**) and **Journals@Ovid** (see pages 3 and 5).

Evidence-based medicine is a growing international trend in the medical field. The concept emphasizes clinical decision-making for individual patients based on both clinical expertise and the current, best available evidence contained in the primary medical literature. The Evidence-Based Medicine Reviews (EBMR) database provides clinicians, researchers and students with the tools to access the appropriate medical literature for clinical decision-making. The database allows users to identify and apply important changes in medical knowledge, without having to read and synthesize for themselves hundreds of journal articles.

Dedication of Falk Library Expansion

A formal dedication of the newly expanded Maurice and Laura Falk Library of the Health Sciences is scheduled for Wednesday, December 9, 1998. The expanded space, located on the second floor of Scaife Hall, includes a new entrance to the library, a relocated circulation desk, study-reading areas and meeting rooms. The Maurice Falk Medical Fund provided a grant of \$125,000 toward the renovation, which has added 6,000 square feet of space to the first floor of the Falk Library. The space was formerly occupied by a food service facility.

Over the years, the Falk family foundations have given generously to support construction of library facilities and maintenance of the History of Medicine Collection. Their initial gift in 1949 led to the creation of the Falk Library, which merged a number of separate health sciences library collections at the University of Pittsburgh. Patricia Mickelson, Director of the Health Sciences Library System, notes "Our dedication ceremony celebrates the Falk family's 50-year history of generosity in supporting the mission of the library and recognizes their major contribution to the scholarly environment and intellectual resources of the health sciences."

At the new entrance, library users are greeted by warm cherry woodwork, a motif that is carried throughout the renovated space and furnishings. The study-reading area includes tables, chairs and individual carrels, and provides seating for 92 people. The expanded space also includes a conference room and two staff rooms to be used for library-related meetings and groups.

Evidence-Based Medicine Reviews (EBMR) provides content from two premiere evidence-based medicine sources: 1) the *Cochrane Database of Systematic Reviews*, and 2) *Best Evidence*. The Cochrane Collaboration's *Cochrane Database of Systematic Reviews* contains systematic reviews of important healthcare interventions. Authors in the Cochrane Collaboration survey hundreds of studies on a topic, select those that meet strict evidence-based medicine criteria, conduct meta-analyses on those studies, and then produce a detailed and structured review of the subject and the findings. The second source in EBMR is *Best Evidence*, a database that contains the ACP Journal Club (a publication of the American College of Physicians-American Society of Internal Medicine), and Evidence-Based Medicine (a joint publication of the ACP and British Medical Journal Group). The editors of *Best Evidence* screen the top clinical journals to identify studies that are both methodologically sound and clinically relevant. Enhanced abstracts of the selected articles are written to provide commentary on the value of the article for clinical practice.

The benefits of searching EBMR are fully realized in combination with the other databases linked through HSL Online, such as MEDLINE and Journals@Ovid, a full text journal collection. The system allows clinicians, from their desktops, to locate the best articles in MEDLINE, view the evidence-based medicine reviews on the subject, and then study the evidence in the original article. Specific features include:

- → "EBM limit" in MEDLINE, allowing users to restrict search results to articles which meet evidence-based criteria
- → Links from MEDLINE to Evidence-Based Medicine Reviews
- → Links from Evidence-Based Medicine Reviews to HSL Online's collection of full text journals, Journals@Ovid
- → Expert topic searches, allowing users to recreate the searches designed by the Cochrane Collaboration in order to review the latest MEDLINE information on a topic.

Currently Evidence-Based Medicine Reviews is available only through the HSL Online Web Gateway, and it is expected to be available through the Ovid Java Client in early 1999. A reminder: in the near future *only* the Web-based versions of HSL Online will be supported with new enhancements. The Windows and Telnet versions of HSL Online will no longer be supported with software updates. Library users are urged to take advantage of the additional features which will be provided exclusively in the Web-based environment.

Dr. Starzl Most Cited Author

Dr. Thomas Starzl, renowned University of Pittsburgh transplant surgeon and researcher, was the most cited scientist in clinical medicine for the period 1981-June 1998. The Institute for Scientific Information (ISI) recently surveyed all articles indexed in the Current Contents/Clinical Medicine database for that period, and the tallies show that Dr. Starzl's research was cited 26,456 times. ISI is the publisher of Current Contents, the Science Citation Index and other databases of scholarly research information in the sciences, social sciences, arts and humanities.

Journals@Ovid: More Full Text

The total number of full text journals available at your desktop through HSL Online will soon increase to nearly 200 titles. The Health Sciences Library System is providing library users with another valuable information tool: **Journals@Ovid**. This new service will provide access to 108 full text journals, and will greatly enhance the Full Text Core Biomedical Collections, Mental Health and Nursing files, which already deliver more that 80 full text journals to users' desktops. Journals@Ovid combines all the capabilities of the Full Text Core Biomedical Collections, with several new features. Benefits for searchers include:

- → Seamless linking: Each Journals@Ovid title is linked to other Journals@Ovid titles, and also to HSL Online databases, such as MEDLINE, PsycINFO and CINAHL. The hypertext feature allows users to display an outline of the document and move immediately to a selected section. In addition, searchers can link directly from the references in an article to other full text articles.
- → Easy browsing: Allows searchers to browse through journals by title.
- → Enhanced Searching: Every word of every article in Journals@Ovid is searchable, including references and captions for graphics.
- → Comprehensive Coverage: Classified advertisements and announcements from the print journals are included.

Eventually, the Full Text Core Biomedical Collections will be incorporated within Journals@Ovid. Currently, Journals@Ovid includes issues from 1996 forward. A complete list of the Journals@Ovid titles can be found on page 3.

Displayed throughout the renovated area are paintings donated by the artist, Dr. Ralph M. Kniseley, who received his MD from the University of Pittsburgh School of Medicine in 1943. After completing a residency at the Mayo Clinic, he pursued a medical career as a clinician, educator and administrator. He was instrumental in developing the specialty of Nuclear Medicine at the Oak Ridge Associated Universities, where he served as chief of research and training. Dr. Kniseley served as Director of the Life Sciences Division of the International Atomic Energy Association in Vienna. He has authored three books on nuclear medicine, and is a recipient of the Georg de Hevesy Pioneer in Nuclear Medicine award and several other medals from professional societies. A lifelong painter and sculptor, Dr. Kniseley has exhibited his works in both one-man and juried shows.

Partners in Information Access Contract

HSLS has been awarded an 18month contract by the Middle Atlantic Region of the National Network of Libraries of Medicine to provide education and information services to public health professionals in Pennsylvania. This is part of the Partners in Information Access project, a joint initiative of the National Library of Medicine (NLM), the NLM's National Network of Libraries of Medicine (NN/LM), the Centers for Disease Control and Prevention (CDC), the Health Resources and Services Administration, the Association of State and Territorial Health Officials, and the National Association of County and City Health Officials.

The goals of Partners in Information Access are to (1) increase public health professionals awareness of the services of the NLM, NN/LM, and CDC; (2) assist public health professionals in getting connected to the Internet; (3) train them in using information technology and information services; and (4) to increase awareness of public health information needs and resources among NN/LM members.

The University of Pittsburgh contract will focus on key staff members of the Pennsylvania Department of Health and county/municipal health departments, the Allegheny County Department of Health, interested members of primary public health associations in Pennsylvania, including the Pennsylvania Public Health Association, and the Pennsylvania Association of School Nurses and Practitioners, and enrolled students and public health professionals receiving continuing education in the University of Pittsburgh Graduate School of Public Health. Activities will include hands-on training classes and specialized exhibits and presentations.
